You are welcome to submit your order directly to our order management.
To do this, please follow the steps below:

- 1) Please fill out the order form above electronically.
 - a. If your order is placed within another offer or project, please include the offer number as a reference in the product selection table.
 - b. Please make sure to enter at least one technical contact person in addition to the commercial contact person, as this contact will receive the access information for the ACME (Automatic Certificate Management Environment) interface.
- 2) Afterwards, please print out the form, sign it by hand by an authorized person and add your organization stamp. Then scan the pages into one PDF document and send it to our order management by e-mail. Alternatively, faxes can be sent.

Depending on whether it is an initial order or a quota change, we process your order as follows:

- 3) **Initial order:**
 - a. After receipt of the order, a new customer account will be created for you on our Public Certificate Service Platform for the issuance of certificates. The named technical contact person will receive the necessary information by e-mail to the e-mail address(es) specified in the form.
 - b. At the same time, we create an item in our billing system for monthly billing. The invoice will be delivered to the billing address provided by you in the way you specify, i.e. either by e-mail or by letter.
- 4) **Quota adjustment:**
 - a. If it is an order to change your quota, we will adjust your certificate quota in your PCSP account and your monthly payment rate.
